REVIEWERS SOUGHT: COMMENT ON PROPOSED MU TIMELINE EXTENSION

Last Friday, May 23, the Office of the National Coordinator and the Centers for Medicare and Medicaid Services published a proposed rule that, among other things, would "provide eligible professionals, eligible hospitals and critical access hospitals more flexibility in how they use certified electronic record technology (CEHRT) to meet meaningful use...The proposed rule would let providers use the 2011 Edition CEHRT or a combination of 2011 and 2014." Comments on the proposed rule are due July 21. AHIMA is reviewing this item for comment. 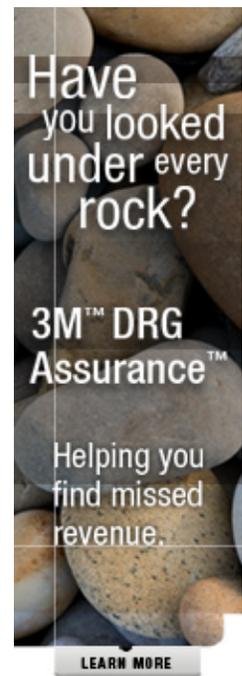

EXPERTS CAUTION: IF YOU'RE ON SOCIAL MEDIA, YOU NEED INFORMATION GOVERNANCE

An article on the *Journal of AHIMA* website reports on last week's National Conference on Managing Electronic Records, held May 19-21 in Chicago, IL, where experts said that because social media platforms have contributed to a transformed landscape, they require information governance policies.

Since legislation related to social media policy is constantly changing, information managers should stay on top of past, present, and future developments. In addition, presenters said that information managers should consider whether their organization has a specific platform that allows retention rules to be set, and whether that application applies rules that delete content after expiration of retention parameters. ALCOHOL AND DRUG ABUSE PRIVACY REGS FORUM TO BE WEBCAST AND RECORDED

A public "listening session" will be held June 11 by the Substance Abuse and Mental Health Services Administration (SAMHSA) to gather public input on updates under consideration to the Confidentiality of Alcohol and Drug Abuse Patient Records Regulations, Title 42 of the Code of Federal Regulations Part 2 (42 CFR Part 2). The regulations were last updated in 1987, before significant changes to both healthcare delivery and information privacy and security regulations. 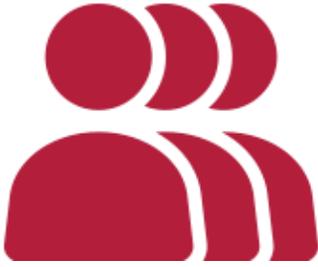

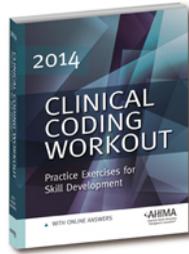

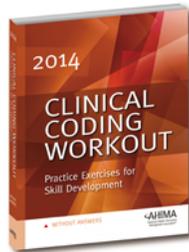
