#### FBI ISSUES HEALTHCARE HACKING WARNING

Reuters reports that the FBI has warned that healthcare industry companies are being targeted by hackers. The warning comes after Community Health Systems, Inc., sustained an attack in which millions of patient records were stolen. According to the article, the FBI "has observed malicious actors targeting healthcare related systems, perhaps for the purpose of obtaining Protected Healthcare Information (PHI) and/or Personally Identifiable Information (PII)."

In April, the agency warned that the healthcare industry's systems were not as secure as other sectors, and could attract hackers. The FBI's warning did not identify specific targets. Read the article.

#### LAST CALL FOR COMMENTS ON ONC INTEROPERABILITY VISION

Earlier this summer, the Office of the National Coordinator (ONC) published a paper describing ONC's broad vision and framework for interoperability, titled "Connecting Health and Care for the Nation: A 10-Year Vision to Achieve an Interoperable Health IT Infrastructure." Input and comments from healthcare stakeholders are requested. Comments are due September 12.

Input will be included in a draft roadmap to be presented to ONC's Federal Advisory Committees in October, and version 1.0 will be posted for public comment in early 2015. Access the document and comment.


